Face masks, QR code check-ins, medical mandates as of 2021

**Is it your duty** to do as the government mandates? Are these mandates legal?

Are the government directives confusing you?

Let's make it clear.

## THE LAW IS ON YOUR SIDE

**Forced mask wearing**, QR code **check-in** or any kind of check-in and any **medical mandates** are illegal according to federal law, regardless of government directives.

This is a time when Australians need to stand together and unite.

### THE BIOSECURITY ACT 2015

- It is illegal for you or the police to harass anyone without a mask, including employees.
- It is illegal for you to force anyone to wear a face mask or undergo any medical procedure, including employees.
- It is illegal for you or the police to harass anyone who chooses not to 'check-in' to your business.

The Biosecurity Act 2015 is federal legislation and supersedes all state law INCLUDING any State of Emergency. This legislation takes precedence. It is the boss.

Under The Biosecurity Act 2015 an individual cannot be forced to wear a mask, be forced to social distance, be forced to use contact tracing, be detained, isolated, tested, vaccinated, medically treated, tested, searched etc in the absence of a Biosecurity control order. No state or federal policy can require you to do any of those things. They are all illegal.

The presumption under the Biosecurity Act 2015 is that an individual is healthy, until proven sick. Measures cannot be directed at a group, as governments are trying to do. If there is a Biosecurity control order in place then it has to have been issued TO THE INDIVIDUAL on a case by case basis by an authorised officer - not police.

Note: Understand that since none of us have this control order on us individually, what is being done is illegal according to the Biosecurity Act 2015, regardless of government directives.

### THE AUSTRALIAN CONSTITUTION

The Constitution OVERRIDES even the Biosecurity Act 2015 with Section 51(xxiiiA) which means the government, including federal, cannot force anyone to undergo any form of medical treatment. This includes the wearing of masks.

### THE COMMONWEALTH PRIVACY ACT 1988 SECTION 94H

- No one can force you to provide medical information including evidence of face mask exemption. It is illegal.
- No one can lawfully track your movements or ask for your personal details i.e. signing into a cafe, supermarket, shopping centre etc. Not even the federal or state government. It is illegal.
- You cannot refuse service to an individual if your business is open to the public. It is illegal.

**YOUR DUTY:** It is your duty to protect consumer rights, not try to enforce government directives. If you are feeling intimidated by police, then place posters encouraging the public to follow a directive, but do not try to enforce them otherwise you are in breach of the Act. You cannot lose when you follow the Australian Constitution, the Biosecurity Act 2015, the Commonwealth Privacy Act 1988, the Disability Discrimination Act 1992 and the Charter of Human Rights and Responsibilities Act 2006. It is in your interests to protect the freedom of your community.

**WARNING:** Most business owners do not understand that breaches of the Privacy Act 1988 are punishable with 5 years imprisonment and or a \$66,600 fine. That is the risk you take. Don't be tricked into following govt directives. If the police threaten you and your business with fines, it is illegal. If you are enforcing government directives regarding masks, check-ins, vaccinations and so on, then what you are doing is illegal.

**EMPLOYEES:** You cannot enforce rules that are illegal. It is not enough to say, "I am just doing what I'm told and I need my job" when you are trying to infringe upon the rights of an individual. Educate yourself about the law.

The government is giving illegal directives and that may well be confusing. Nevertheless, these directives are still illegal and not in the interests of the Australian people.

Know your legal rights so that you maintain your freedom for yourself, your loved ones, our local community and our country.
