I would like to submit to you today a Charge sheet and summons to report a crime. I would also like to bring to your attention the significant and irrefutable forensic evidence and hundreds of witness statements from victims, whistleblowers, and experts to confirm serious harm, injury and death caused by the COVID-19 vaccines.

Crimes being cited are *misfeasance in public office, misconduct in public office, conspiracy to commit grievous bodily harm, conspiracy to administer a poisonous and noxious substance to cause serious harm and death. gross negligence, manslaughter, corporate manslaughter, Corruption, fraud, black male, murder, conspiracy to commit murder, terrorism, genocide, torture, crimes against humanity, false imprisonment, multiple breaches of our human rights, war crimes, multiple breaches of the Universal declaration on bioethics and human rights, the international covenant on civil and political rights, international covenant of economic, social and cultural rights, declaration of Helsinki, The Nuremberg code 1947, the Declaration of Geneva and breaches to the constitution of the commonwealth of Australia.*

This is an international crime and could potentially be the world's largest criminal investigation. Investigations are taking place in numerous countries around the world. The evidence is overwhelming and irrefutable.

If you are wondering why you have not heard about any of this, is because there is a deliberate blanket campaign of misinformation and censorship

promoted by the Government and the mainstream media. The Australian Government controls the mainstream media and all Government ministers, health ministers and the mainstream media are implicated in the alleged crimes.

So, in accordance with the Crimes Act we call upon you to assist us in the closure of all vaccine centers within your jurisdiction as pertaining to the warrants I will present to you shortly.

The Crimes Act 1914 gives any man or woman the authority and the power to prevent crime, we also have authority to use force as is reasonable, necessary, and proportionate in order to prevent a crime from happening.

You may be resistant to this; however, you have a duty to protect the people, you are public servants who we pay with public taxes and public money. You work for us. If the crime of injury and serious harm and death is being committed, it is incumbent upon you in your office in the police service on the oath which you swore to protect us, the people, from said harm. If you're in attendance, it is your duty to gather evidence and seize the weapon, which in this case, are the vaccine vials.

The vaccine vials should be taken into protective custody and detained in your property evidence stores to be independently forensically tested as a matter of urgency. This is a factor in law.

The law is the same whether you are a police constable in uniform or whether you are a citizen or a man or woman that is sovereign. The police have a duty, that duty is to respond and act accordingly. If the police failed to do their job, they are committing an offense of misconduct in public office and perverting the course of justice. If they know offenders are responsible for these crimes and they do anything to assist those offenders or prevent those crimes from being detected or deliberately frustrate the criminal investigation, they are also guilty of an offense of assisting unknown offenders. May I remind you that you work for the people, you do not work for the government.

It is the government ministers, the civil servants and the media bosses who are committing these disgusting and heinous atrocities against millions of people throughout Australia. It is ridiculous to expect us to address members or part members of Parliament. They are the very people committing these crimes. We do not speak to the offenders. That is the job of the police. And these people must be arrested.

So, we now demand that you assist us enforcing all vaccine centres within your jurisdiction to cease and desist with immediate effect. We expect you to be in attendance with us at local vaccine sites so that we can bring a halt to any further crimes, serious harm, injury, and death. We also demand that you make an official public statement to the people of Australia making them aware of this criminal investigation, warning of the dangers of this experimental drug and inviting them to come forward to provide further evidence of vaccine injury, harm and death.

Finally, we can now provide you with all the legal documents and warrants in relation to this case, and the crime event numbers.
